Subject: Notice on Trading Suspension of Banque Pour Le Commerce Exterieur Lao Public for operating Stock Split.

- According to the Notice on Process of Stock Split Operation, No 1456/LSX, dated 2 November 2023;
- According to the Proposal of BCEL on Stock Split Making, No 0219/BCEL, dated 21 January 2025.

Lao Securities Exchange (LSX) would like to inform you that according to a proposal from Banque Pour Le Commerce Exterieur Lao Public (BCEL) for changing its par value or stock split from 5,000 kip per share to 1,000 kip per share. Therefore, in accordance with relevant regulation, LSX shall suspend the trading of BCEL's shares and put the "H" sign during on 11th-14th and 17th February 2025 (5 trading days) for stock split making as per the request of BCEL.

Afterwards, LSX will resume the trading of BCEL's shares from 18th February 2025 onward.
